### I. Promotion of the FX Global Code to Market Participants in Japan

Members reported the progress of actions to promote adoption and adherence to the FX Global Code (the Code) in the Tokyo market. In addition, Mr. Fujihira, Associate Member of the Committee, explained initiatives to develop reference materials together with the Sub-Committee on Code of Conduct to support works by market participants to for adoption and adherence to the Code, in response to requests from regional banks.

Furthermore, Mr. Hoshino, Chairperson of the Committee, proposed that the Sub-Committee would be tasked with devising plans for setting up a public register for the Tokyo market, and the Committee approved this proposal.

Mr. Hoshino and Mr. Shigemoto, Secretary of the Committee, reported recent works by the Global Foreign Exchange Committee (GFXC) toward its next meeting in November. Mr. Hoshino proposed to have another opportunity to discuss further among members before the meeting, and the Committee approved this proposal.

# II. Recommendation for the Calculation of the Fixing Rate of NDF Transactions against the Yen

Based on the discussion at the previous meeting, Mr. Hirota reported that the Committee had announced on its website its decision to withdraw the current recommendation regarding the "JPNU" page for the calculation of the fixing rate of NDF transactions against the yen. Mr. Ooki referred to the

Committee's ongoing consideration to create reference rates. Mr. Hoshino proposed to continue holding discussions while consulting with other bodies on the handling of the situation, and the Committee approved this proposal.

#### III. Sub-Committee on BCP

Mr. Koyanagi, Associate Member of the Committee, reported that the joint BCP exercise among three markets held on October 18<sup>th</sup> had been completed as scheduled overall. Mr. Koyanagi also mentioned that the Committee would consider some cases of BCP implementation upon the realization of adverse geopolitical events and large-scale natural disasters.
