I. Replacement of the Observer

Mr. Inoue, Chairperson of the Committee, reported that Mr. Otsuki would succeed Mr. Ikoma as the Observer of the Committee.

II. Reappointment of Members

While Mr. Ohkuma and Ms. Kuwano had expired their term of office, they re-applied for staying as a member of the Committee, which approved unanimously.

III. Update on Re-adherence to the GCoC in Japan

Mr. Kanato, Vice-Chairperson of the Committee, introduced the status of adherence to the revised FX Global Code (hereinafter, "Code") in Japan and shared information on the follow-up activities to those who have not yet readhered to the Code, which are in progress (1) through the members of the Committee and (2) through the secretariats of the Japanese Bankers Association, Japan Securities Dealers Association, and Financial Futures Association of Japan. In addition, in conjunction with the follow-up activities, he proposed to develop a contact list of the parties that have declared adherence and indicated additional information that would be required for the procedure, which was approved unanimously.

IV. Progress related to the GFXC

Mr. Shimizu, Secretary of the Committee, reported that (1) members of the new WG for promoting Code adherence, which was established at the GFXC meeting held on June 27-28 this year and (2) candidates for GFXC Vice Chair for the period from 2023 to 2024 are wanted.

In this context, Mr. Inoue, Chairperson of the Committee, reported that proceeding the foreign exchange transaction data sharing towards the 2024 Code review was discussed and opinions were collected at the GFXC meeting. In addition, Mr. Hoshino mentioned that several business operators made presentations on the use of new technologies for foreign exchange settlement at the GFXC meeting and that it would be a good idea to invite such operators to introduce their advanced approaches at the Committee in the future.

V. Result of the Turnover Survey conducted in April 2022

Mr. Hari, Associate Member of the Committee, overviewed the results of the Turnover Survey (April 2022) and reported that this would be published today.
