I. Resignation and Election of Members

Mr. Inoue, Chairperson of the Committee, reported that the term of Mr. Ooki as a member would shortly expire. Mr. Ooki expressed his wish to serve for another term and was reelected unanimously.

Mr. Noguchi reported the financial result of the Seminar.

3. The Sub-Committee on Public Relations

Mr. Ooki, Chairperson of the Sub-Committee, reported that the website of the Committee was updated.

4. The Sub-Committee on BCP

Mr. Okabayashi, Associate Member of the Committee, reported that it was decided to invite major market players such as market makers to participate in the BCP exercise.
